**AN ORDINANCE OF THE HAINES BOROUGH AMENDING BOROUGH CODE
TITLE 2 TO UPDATE THE GENERAL AGENDA ORDER FOR REGULAR
BOROUGH ASSEMBLY MEETINGS.**

BE IT ENACTED BY THE HAINES BOROUGH ASSEMBLY:

Section 1. Classification. This ordinance is of a general and permanent nature and the adopted amendment shall become a part of the Haines Borough Code.

Section 2. Severability. If any provision of this ordinance or any application thereof to any person or circumstance is held to be invalid, the remainder of this ordinance and the application to other persons or circumstances shall not be affected thereby.

Section 3. Effective Date. This ordinance shall become effective immediately upon adoption.

Section 4. Purpose. This ordinance amends Title 2 Chapter 100 to update the general agenda order for regular borough assembly meetings. The code is amended as follows:


2.10.020 Order of business.

The assembly shall establish an agenda format to address the appropriate order of business. The format may vary according to the needs of the regular or special meeting and shall identify each agenda item that may be acted upon with sufficient descriptions that a reasonable person would understand the topic or subject. The following order of business shall be in general use:


- A. Call to order;
- B. Pledge to flag;
- C. Roll call;
- D. Approval of agenda/consent agenda;
- E. Approval of Minutes of previous meeting;
- F. ~~Audience participation/appearance requests~~ Public comments;
- G. Mayor's comments/report;
- H. Public hearings;
- I. Staff/Facility Reports of manager and departments;
- J. ~~Bids/proposals received~~;
- K. ~~Expenditure/grant approval requests~~;
- LJ. ~~Reports of standing committees~~
Committee/Commission/Board Reports & Minutes;

- ~~M. Reports of special committees;~~
~~N. Consideration of resolutions, petitions and memorials;~~
