

AN ORDINANCE OF THE HAINES BOROUGH AMENDING HAINES BOROUGH CODE 2.08.040 AND 2.16.070 TO REVISE THE COMPENSATION AMOUNTS FOR THE ASSEMBLY MEMBERS AND MAYOR.

BE IT ENACTED BY THE HAINES BOROUGH ASSEMBLY:

Section 1. Classification. This ordinance is of a general and permanent nature and the adopted amendment shall become a part of the Haines Borough Code.

Section 2. Severability. If any provision of this ordinance or any application thereof to any person or circumstance is held to be invalid, the remainder of this ordinance and the application to other persons or circumstances shall not be affected thereby.

Section 3. Effective Date. This ordinance shall become effective immediately upon adoption.

Section 4. Purpose. This ordinance amends Title 2 Sections 08.040 and 16.070 to revise the compensation amounts for the assembly members and Mayor.

The code is amended as follows:


2.08.040 Compensation of assembly members.

Each member of the assembly shall receive compensation at the rate of ~~\$100.00~~ **\$125.00** for each regular and special meeting of the assembly attended. **Each member of the assembly shall also receive compensation at the rate of \$50.00 for each budget committee of the whole meeting.** Any assembly member who resides at a distance greater than 20 miles from the meeting site shall receive an additional \$10.00 for every regular **meeting, and special meeting, and budget committee of the whole meeting** attended to compensate for travel costs. No compensation shall be paid for other meetings attended. **In the event of consecutive meetings occurring on the same day, assembly members shall receive attendance and travel compensation for only one meeting and, in the event the meetings involve different rates, it shall be paid at the higher amount.** Assembly members shall also receive the life insurance, major medical, dental and optical, workers' compensation and PERS benefits available under the current plans adopted by the borough for themselves only and if they have elected to do so. Assembly members may elect, at their own expense, to provide spousal and dependent children coverage as allowed under the respective plans. An elected official may not receive compensation for service in addition to the salary compensation received as an elected official. Per diem payments or reimbursement for expenses are not considered compensation under this section. Elected officials may also receive compensation as provided by ordinance if the elected official is a member of, and not a department head of, the Haines volunteer fire department and/or police reserves.


2.16.070 Compensation of the mayor.

The mayor of the borough shall be paid a salary of ~~\$1,000~~ **\$1,250.00** per month, provided, however, if the mayor is out of the borough for a period of more than 15 days (exclusive of time spent on borough business), the mayor's salary shall be suspended for the entire period of absence and paid to the deputy mayor as prorated by the chief fiscal officer. The mayor shall not receive any other form of compensation from the borough other than that provided under this section and HBC 2.92.010 as an elected official. Per diem payments or reimbursement for expenses are not considered compensation hereunder.
